Methods and Materials for Containment and Clean Up

Remove all ignition sources. Do not touch or walk through spilled product. Stop leak if you can do it without risk. Precautions for Safe Handling

Keep away from sparks or flame. Where flammable mixtures may be present, equipment safe for such locations should be used. Use clean tools. When transferring large volumes of product, metal containers, including trucks and tank cars, should be grounded and bonded. These products have a low vapor pressure and are not expected to present an inhalation hazard under normal temperatures and pressures.
